## Subject: Review application of M/s. Gland Pharma Limited under para 31 of DPCO 2013 against NPPA Notification NO. S.O.2858(E) dated 20.9.2013 fixing ceiling price of Scheduled medicine Heparin Sodium Injection(5000IU/ml).

Whereas Government of India, vide price fixation Order S.O. NO. 2858(E) dated 20.9.2013 fixed ceiling price of scheduled medicine Heparin Sodium Injection (5000IU/ml) under the provisions of Drugs (Prices Control) Order, 2013.

2. And whereas aggrieved by the above notification M/s. Gland Pharma Limited (hereinafter referred to as the petitioners) had represented to the reviewing authority against the said price fixation. Personal hearing was granted to the Petitioners by the Department of Pharmaceuticals on 13.11.2013. The Petitioners were represented by S/Shri Sandip Dey. GM-Sales & Marketing, Shailesh Pandey, Sr. Zonal Sales Manager. On behalf of the NPPA Shri S.K. Bhatt, Deputy Director (Tech) attended the hearing. Shri V.K. Tyagi, Dy. Industrial Adviser, D/o Pharmaceuticals was also present during the hearing as a technical expert.

3. The issues involved in the review application have been examined based on the record of note of discussions of the personal hearing, other documents on record and the Government has decided as under:

"NPPA is directed to revalidate the data by appropriate survey or evaluation as empowered under para 9 of the DPCO 2013. However, the data to be revalidated by NPPA should be broad based and not linked only to one source. NPPA may use their website and other known sources for such a survey. The company in the meantime is directed to maintain the ceiling price already notified by NPPA.
