ORDER

Subject: Review applications of M/s Wockhardt Limited against fixation of ceiling prices for Dexamethasone Injection 4mg/ml and Gentamycin 40mg/ml vide NPPA notification S.O. No. 1157(E) dated 28.4.2014 under Drugs (Prices) Control) Order, 2013 (DPCO, 2013).

Whereas Government of India, vide price fixation Order S.O. No. 1157(E) dated 28.4.2014 fixed ceiling prices of Dexamethasone Injection 4mg/ml and Gentamycin 40mg/ml.

- 2. And whereas aggrieved by the above notifications M/s. Wockhardt Limited (hereinafter referred to as the Petitioners) had represented to the reviewing authority against the said price fixation orders. Personal hearing was granted to the Petitioners by the Department of Pharmaceuticals on 3.6.2014. The Petitioners were represented by Shri Shahnawaz Khan, Vice President and Shri S. Sethi, G.M. On behalf of the NPPA Shri Manish Goswami, Deputy Director and Shri Naresh Arya, Deputy Director attended the hearing.
- 3. The issues involved in the review application have been examined based on the record note of discussions of the personal hearing, other documents on record and the Government has decided as under:
 - i. Once the brands/generic versions of a particular medicine, having MAT of more than 1%, have been identified, it is only simple averaging of prices of all such versions, which determines ceiling price for that medicine. Para 4 of DPCO, 2013 also mentions the same. Therefore, the procedure followed by NPPA is in line with provisions of DPCO, 2013.
 - ii. The DPCO, 2013 does not distinguish between sales through retailer shop or through hospital outlets. It is only the "Price to retailer", which is captured by IMS, that is taken into account for calculation of ceiling price. Therefore, any such further classification or exclusion of hospital sales may not be in line with provisions of DPCO, 2013.
