Ensuring compliance of the price capping of the Primary Knee and Revision Knee along with maintaining its uninterrupted supply - regarding. Sub:

#### Sir/Madam,

Whereas Government has fixed the ceiling price of knee implants and whereas in the larger public interest, uninterrupted supply of knee Implant System will have to 1. be ensured by the Government;

Now therefore, it has been decided to invoke the powers under paragraph 3 of 2. Drugs (Prices Control) Order, 2013 (DPCO, 2013) which provides as under:-

"The Government may, - (i) with a view to achieve adequate availability and to regulate the distribution of drugs, in case of emergency or in circumstances of urgency or in case of non-commercial use in public interest, direct any manufacturer of any active pharmaceutical ingredient or bulk drug or formulation to increase the production and to sell such active pharmaceutical ingredient or bulk drug to such other manufacture(s) of formulations and to direct formulators to sell the formulations to institutions, hospitals or any agency as the case may be;

for the purpose of giving any direction under sub-paragraph (i), call for such (ii) information from manufacturers of active pharmaceutical ingredients or bulk drugs or formulations, as it may consider necessary and such manufacturer shall furnish the required information within such time the Government may fix." 4

The Companies are directed:-

3.

(i) to furnish the production figures for 2015-16; 2016-17 and 2017-18;

(ii) to maintain production/import/supply of the orthopedic knee Implant Systems at the same levels before August, 2017;

(iii) to submit a weekly report on orthopedic knee Implant System produced and distributed.

4. This order will be valid initially for six months period.

5. This issues with the approval of Hon'ble Minister for Chemicals & Fertilizers.
